### September is National Preparedness Month. Is your disaster plan in place?

September is National Preparedness Month. The Town of Gilbert and FEMA are urging residents to be prepared with a few helpful tips.

First, it is important to be informed. This means learning about possible hazards, threats or safety issues in and around your community. Keep a list of emergency phone numbers and make sure it is up-to-date. And, practice an emergency plan at home with your family.

It is also important to make a plan. Determine how you



and our family and friends will communicate during an emergency. Pick a room in your home to use as a shelter in case authorities advise residents to stay in place. Choose an evacuation route with alternate routes in case of an evacuation.

Residents should also get a kit. Fill a plastic tub or container with items that will hold you and your family through a disaster. Include things like food, bottled water, flashlights, a battery-powered radio, a first aid kit and copies of your important documents. Don't forget extra necessities like medication and batteries.

### Tips to protect against burglaries

In an effort to reduce this number, the Gilbert Police Department has implemented the Lock 'em Out Program Against Burglary. The primary objective of the Lock 'em Out Program is to assist Gilbert residents in identifying potential security weaknesses through a personalized security survey performed "free of charge" by a Gilbert Police Department Crime Prevention Specialist. The program is also designed to make citizens more aware of the risks of burglary and to educate them on target hardening strategies. The Lock 'em Out program name is an acronym used to better describe devices and measures necessary to better secure a property as shown below:

- L Latches and Locks
- O Outdoor Lighting and Landscaping
- C Clearly Visible Property Identifiers
- K Keeping Garage Door Closed
- E Entry Peep Viewers
- M Metal Security Screens/Doors
- O Operation Identification
- U Use of Security Bar
- T Timers

Many of the recommendations call for minor modifications to be made to windows, doors and other fixtures within your residence. When you implement these recommendations caution must be exercised to prevent personal injury or unintended damage.

Please understand that the recommendations in this booklet are security recommendations and nothing is 100% guaranteed to prevent burglaries.

### Bulk trash pickup schedule

October 14-20 November 18-24 December 16-22

Bulk trash items can be placed at the curb NO EARLIER than 48 hours before the first Monday of the bulk trash pickup week. Any bulk trash left at the curb earlier will receive a CCR violation.

Black trash cans with regular trash is picked up on Wednesday; blue recycling cans are picked up on Friday.

# No time or stamps? No checks? No worries! Try automatic payment of your HOA dues!

Why bother with the hassle of remembering when your dues are due, finding a stamp, then mailing in your check? With Automatic Payment Authorization, your association fees are automatically deducted from your checking account at the start of each quarter. Dues for Towne Meadows are \$50 per quarter.

The authorization form can be downloaded at www.tmhoa. com/arc.htm. Fill out the form, attach a voided check, and return both to Renaissance Community Partners at least 15 days before the payment is due. Then you'll never have to worry about finding a stamp again!

### Making changes to the front of your property? Submit an ARC request

Planning to change your front landscape from grass to desert? Are you installing a driveway extension? Before any work begins, homeowners must submit an Architectural Request Form to the Towne Meadows Architectural Request Committee.

The form can be downloaded at http://www.tmhoa.com/arc.htm. Submissions will not be considered if the homeowner is not current



with the payment of assessments. Some landscaping changes

require adjacent owners input prior to installation. Also, your improvements may require a permit from the City/County Building Department. You should check with the department about permits before starting any work. All work must be completed within 90 days of approval.

permanently etching the vehicle's 17 digit VIN number on each piece of glass on the vehicle. Please bring your current Arizona registration (out of state vehicles not eligible), current proof of insurance and

driver's license to the event.
